

# Cashback Program – Terms and Conditions

These Terms and Conditions (“T&Cs”) govern participation in the Company’s Cashback Program (“Program”). By enrolling in or participating in the Program, the client (“Client”) acknowledges that they have read, understood, and agreed to be bound by these T&Cs and by the Company’s general Terms and Conditions.

## 1. Eligibility and Enrollment

- 1.1. Participation in the Program is subject to the Client's explicit acceptance of these T&Cs.
- 1.2. Upon acceptance, a dedicated "Cashback Wallet" will be created in the Client's profile.
- 1.3. The Program is available only for Live Trading Accounts. Demo accounts are not eligible.
- 1.4. Trades executed using any type of bonus or credit are not eligible for cashback.

## 2. Cashback Wallet

- 2.1. All cashback amounts earned under the Program will be credited exclusively to the Client's Cashback Wallet.
- 2.2. Direct withdrawals from the Cashback Wallet are not permitted.
- 2.3. The Client may transfer funds from the Cashback Wallet to a trading account or to any other wallet, subject to a minimum transfer amount of USD 10 (or equivalent).

## 3. Cashback Calculation and Credit

- 3.1. Cashback is calculated and credited automatically at intervals of approximately every 10 minutes.
- 3.2. Cashback is generated only for eligible trades where the time between opening and closing the trade exceeds 3 minutes (180 seconds).
- 3.3. Cashback is only given once a trade is closed. No cashback for open trades.
- 3.4. Cashback is calculated on a per-lot basis, depending on the account type and instrument, as follows:

- **Standard Account:** USD 1 per lot for Forex majors and Gold

- **ECN Pro Account:** USD 0.5 per lot

- **VIP Account:** No cashback

### 3.5. Example:

#### **A – Eligible trade**

- > Client opens a buy trade on EURUSD on a Standard account
- > Volume = 1.00 lot
- > Trade Open time = 12:33
- > Trade Close Time = 12:37
- > Total Cashback amount = \$1

#### **B- Ineligible trade**

- > Client opens a buy trade on EURUSD on a Standard account
- > Volume = 1.00 lot
- > Trade Open time = 12:33
- > Trade Close Time = 12:34
- > Total Cashback amount = \$0

## 4. Exclusions and Limitations

4.1. No cashback will be generated for:

- (a) Trades executed under any bonus, credit, or promotional balance;
- (b) Trades closed within 3 minutes (180 seconds) from opening;
- (c) Trades executed on demo accounts;
- (d) Any trades or account types not explicitly stated as eligible.

4.2. The Company reserves the right to determine, at its sole discretion, whether a trade qualifies for cashback.

## 5. Abuse, Clawback, and Termination

5.1. In the event that the Company determines that the Client has engaged in any abusive, manipulative, or otherwise non-compliant trading activity, or has breached these T&Cs or any other Company terms, the Company reserves the right, at its sole discretion, to:

- (a) Claw back (reverse) any cashback already credited;
- (b) Exclude the Client from the Program, temporarily or permanently; and/or
- (c) Take any other action permitted under the Company's general Terms and Conditions.

5.2. The Company's decision in such matters shall be final and binding.

## 6. Amendments and Termination of the Program

6.1. The Company reserves the right to amend, suspend, or terminate the Program, or to modify these T&Cs, at any time, with or without prior notice, to the extent permitted by applicable law.

6.2. Any such changes will be effective from the time they are published on the Company's website or communicated to Clients.

## 7. General

7.1. The Program is offered at the Company's sole discretion and is subject to the Company's general Terms and Conditions at all times.

7.2. In case of any discrepancy between these T&Cs and the Company's general Terms and Conditions, the latter shall prevail.
