## 1. General

- 1.4 Eligible countries for this promotion include Philippines, Thailand, Vietnam, Indonesia, China, Japan, Cambodia, Singapore, and Malaysia, and participation from any other jurisdictions may be restricted at the sole discretion of Vittaverse in accordance with applicable regulations.

## 2. Campaign Period

- 2.1 The promotion will start on February 17, 2026 and end on February 25, 2026.
- 2.2 The campaign duration is strictly limited to 8 days, 8 minutes, and 8 seconds from the official launch time.
