

## Deposit Bonus – Terms & Conditions

These Terms and Conditions ("Terms") govern participation in the Deposit Bonus Program offered by Vittaverse Ltd. By participating in this promotion, clients agree to comply fully with the following terms:

### Eligibility & Account Restrictions

This promotion is available to new and existing clients of Vittaverse who are making a **deposit** during the campaign period.

- The promotion applies exclusively to **Standard Accounts**. It is **not applicable** to ECN, Copy Trading, or any other special account types.
- Only clients who have completed **full KYC verification**, including valid proof of identity are eligible.
- Clients must be at least 18 years of age and reside in a jurisdiction where such promotions are legally permitted.

### Bonus Structure

Clients will receive a deposit based trading bonus according to the following structure:

Deposit Amount (USD)	Bonus Percentage
100 – \$300	20% bonus
\$301 – \$1,000	25% bonus
More than \$1,000	40% bonus

- The bonus is credited in the form of trading credit to the eligible account.

## Bonus Usage Rules

## Withdrawal Conditions

Clients may withdraw profits generated from bonus trading under the following conditions:

- **If any withdrawal is made during the 30 days bonus period**, the same amount will be deducted from the bonus credit that was applied to the account.
- Profits earned through trading with the bonus funds are **fully withdrawable only if all conditions** are met.
